1	<p>By-Law # 3: The Klub Kombi</p> <p>This section is from the By-Laws and it is proposed to be added to the constitution. This will help to ensure that Klub Kombi is protected by the rights of the members as it will require a vote from the membership before any actions may be taken.</p>	<p>24 The Klub Kombi</p> <p>3. 1 The 1955 Volkswagen Type 2 van, which is owned by the Club, shall be referred to in this By-Law as the “Klub Kombi”.</p> <p>3. 2 The Klub Kombi is a valuable asset which was donated to the Club. It has been re-built, to date, using club member labour, numerous parts and monetary donations from members and sponsors, plus club fund-raising activities.</p> <p>3. 3 It is intended that the Klub Kombi be completed as the promotional flagship of the Club and, as such, shall be retained for the foreseeable future.</p> <p>3. 4 If, for whatever reason, the Club has to relinquish ownership of the Klub Kombi, this shall only be undertaken after a vote in favour of the motion is passed by at least 50% plus one (1) of Full Members at a specially convened meeting, which may or may not be held in conjunction with any General or Annual General Meeting of which a minimum of one month’s notice in writing has been forwarded to all current members detailing reasons for disposal.</p> <p>3.5 Should the Association find it necessary to relinquish ownership of the Klub Kombi, the vehicle may only be gifted or donated to an Australian or international organization, recognised for the preservation of historic vehicles.</p>

3	<p><u>6 MEMBERSHIP</u></p> <p>b) A person directly related to a Full Member and residing at the same address, may become a Family Member on payment of one half of the annual membership subscription. A Family Member is entitled to vote on any matter but will not receive regular copies of the club magazine.</p>	<p>b) A person directly related to a Full Member and residing at the same address, may become a Joint Member on payment of one half of the annual membership subscription. The Joint Member is not entitled to vote or receive a regular printed copy of the magazine. Current family members will continue to retain their current rights.</p>
4	<p>c) A person who does not meet the criteria in (a) or (b) may become a Social Member on payment of the full annual membership subscription. Such members shall not be eligible to vote or stand for Committee positions, but will receive regular copies of the club magazine</p>	<p>c) A person may become an Associate Member with a discount of \$10.00 on the Full Membership fee. An Associate Member shall be able to apply for the Conditional Registration Scheme but will not be eligible to vote or stand for Committee positions or receive printed copies of the club magazine.</p>
